The Deposit for service of \$30 is refundable only upon closing your account or after 2 consecutive years of good standing with no late payments. \*Water bills are due on the 25<sup>th</sup> every month by 5pm (WHETHER IT FALLS ON A WEEKEND OR A HOLIDAY) or be through the slot and on the office floor before 8 a.m. the first working day after the 25<sup>th</sup>. If the bill is still not paid by 5pm on the 25<sup>th</sup> or 8 a.m. the following working day thereafter, a **25% LATE CHARGE** will added and will be subject to turn off pending a letter of termination. **PEASE DO NOT IGNORE THE TERMINATION LETTER!** When you receive your letter of termination by the District it will include the total amount to be paid including the late charge. 15 days after receiving the letter of termination you will receive a 48 hour notice stating that your service will terminated. Once your service has been shut off, a **\$75.00 reconnect fee** will be added. We will not accept a check for service reinstatement.

The District has personnel on call 24 hours a day. All valves on the Districts side of the meter are to be worked by District personnel **ONLY**. If you need the water shut off please call the District (This service is at no cost to you). If the meter or valves are broken by you or your plumber, the account holder will be held accountable for the cost of repairing or replacing the parts.

The District office is open from 8:00 a.m. to 5:00 p.m., Monday through Friday excluding weekends and holidays. For your convenience, the District accepts online and auto-payments the District website, as well as it has a payment drop slot in the office door. The District also accepts Checks and Credit Cards. Bills can be paid over the phone with a Credit Card.

The undersigned hereby makes application to MEINERS OAKS WATER DISTRICT for water service to be supplied at the aforementioned service location to commence on the date shown and agrees to pay for such service promptly as bills are rendered and in accordance with rates, rules and regulations of the District.
