The Deposit for service of [**Residential: \$50, Commercial: \$75, Agriculture: \$150**] is refundable only upon closing your account or after 2 consecutive years of good standing with no late payments. \*Water bills are due on the 25<sup>th</sup> every month by 5pm (WHETHER IT FALLS ON A WEEKEND OR A HOLIDAY) or be through the slot and on the office floor before 8 a.m. the first working day after the 25<sup>th</sup>. If the bill is still not paid by 5pm on the 25<sup>th</sup> or 8 a.m. the following working day thereafter, a **25% LATE CHARGE** will added and will be subject to turn off pending a letter of termination at 60 days delinquent. **PEASE DO NOT IGNORE THE TERMINATION LETTER!** Each customer will be contacted via phone, notice, mail or in person regarding the pending shutoff no less than 7 days prior to the shutoff. The customer will be advised of the reconciliation agreement. The termination notice will include all the requirements listed in Health and Safety Code 116908. If District contact has not been made by the 8<sup>th</sup> day, service will be terminated. Once your service has been shut off, a **\$50.00** (normal business hours) or **\$150** (after-hours) **reconnection fee** will be added to the account balance. We will not accept a check or credit card for service reinstatement. **Cash Only**

The District has personnel on call 24 hours a day. All valves on the Districts side of the meter are to be worked by District personnel **ONLY**. If you need the water shut off please call the District (This service is at no cost to you). If the meter or valves are broken by you or your plumber, the account holder will be held accountable for the cost of repairing or replacing the parts.

The District office is open from 8:00 a.m. to 5:00 p.m., Monday through Friday excluding weekends and holidays. For your convenience, the District offers online bill pay at [www.meinersoakswater.com](http://www.meinersoakswater.com) and has a secure payment drop slot in the office door. The District accepts cash, checks and all major credit cards (credit card only for phone payments).

The undersigned hereby makes application to MEINERS OAKS WATER DISTRICT for water service to be supplied at the aforementioned service location to commence on the date shown and agrees to pay for such service promptly as bills are rendered and in accordance with rates, rules and regulations of the District. It is further agreed in the event an action is commenced in a Court of Law by the District to collect any obligations incurred by the use of the water service to pay reasonable attorney's fees if said action is successful.
